# Terms And Conditions St Brendan's Park FC – Disney 22 draw

#### The Promoter

The Promoter is St Brendan's Park FC from it's registered address at Buntalloon, Tralee, County Kerry, Ireland.

#### Main Prize

- The Prize provided is a trip for two adults and two children to Disneyland in Florida including flights and a pass to 3 parks along with \$1,000 in spending money
- In lieu of the prize, a voucher for €7,000 for Sol Travel can be chosen allowing travel to any destination
- The prize cannot be exchanged for cash
- A Maximum of 2,999 tickets will be sold
- Entries close at midnight on Saturday, April 16<sup>th</sup>, 2022 or earlier if the maximum number of tickets is reached
- The draw will take place at 8pm on Easter Sunday, April 17<sup>th</sup>, 2022

### Early Bird Prize

- All tickets purchased before midnight on Friday, December 24<sup>th</sup> will be entered in an early Bird draw
- The prize for this draw is as follows:
  - A family hotel break for 2 adults and 2 children at Ormond Hotel Kilkenny including 2 nights Bed and Breakfast and 1 evening meal
- The Early Bird draw will take place on Sunday, December 26<sup>th</sup> at 8pm

### **Entry Requirements**

The Raffle Draw is open to anyone aged 18 or over as at the date of the draw who has purchased a Disney 22 ticket on or before the above closing dates. By taking part in this Raffle Draw, the participant is deemed to have read and understood the terms and conditions of this promotion and agrees to be bound by them. #### How to Enter the Raffle Draw

On purchase of an online ticket for the Raffle Draw participants will receive an email with their raffle ticket number, all purchasers of tickets are automatically entered.

At the point of purchase of the raffle ticket, purchasers will be asked to provide their first name, last name, email address, postal address, and contact number, which will be inputted online. Failure to provide any of the foregoing information or accurate contact details at the point of purchase may result in an inability on the part of the Promoter to contact the winner. The Promoter accepts no responsibility or liability to the winner for any failure on the part of the winner to provide full and accurate contact information. Raffle Draw tickets are priced at €23.00 plus €2.00 processing fee. #### Winner Selection
