

Terms And Conditions

Parke Keelogues Crimlin GAA Club – 5 years in Croker draw

The Promoter

The Promoter under a licence granted by District Court Area of Castlebar is Parke Keelogues Crimlin GAA Club, its registered address at Parke, Castlebar, Co Mayo, Ireland.

Main Prize

- The Prize provided is two 5-year Premium tickets at Croke park valued at €8,250 each.
- One winner will win both tickets
- Entries close at midnight on Thursday, June 16th, 2022
- The draw will take place at 8pm on Friday June 17th, 2022

Early Bird Prize

- All tickets purchased before midnight on Thursday, April 14th, 2022 will be entered in an early Bird draw
- The prize provided for this draw is 2 All-Ireland Football Final tickets 2022 plus overnight accommodation and €100 spending money
- The Early Bird draw will take place on Friday, April 15th, 2022

Entry Requirements

The Raffle Draw is open to anyone aged 18 or over as at the date of the Raffle Draw who has purchased a 5 Years in Croker Draw ticket on or before the above closing dates. By taking part in this Raffle Draw, the participant is deemed to have read and understood the terms and conditions of this promotion and agrees to be bound by them. In the event of a club or syndicate winning, the person buying the ticket for the syndicate will represent the interest of the syndicate

How to Enter the Raffle Draw

Entry is by means of an online entry via <https://pallaslotteries.ie/product/parke-5-years-in-croker>. A limited number of printed tickets will be made available for non-internet users. On purchase of an online ticket for the Raffle Draw participants will receive an email with their raffle ticket number, all purchasers of tickets are automatically entered.

At the point of purchase of the raffle ticket, purchasers will be asked to provide their first name, last name, email address, postal address, and contact number, which will be inputted online. Failure to provide any of the foregoing information or accurate contact details at the point of purchase may result in an inability on the part of the Promoter to contact the winner. The Promoter accepts no responsibility or liability to the winner for any failure on the part of the winner to provide full and accurate contact information. Online draw tickets are priced at €23.00 plus €2.00 processing fee. By purchasing a ticket, entrants agree to be bound by these terms and conditions (please retain a copy of these terms and conditions for your reference) and to take part in any publicity relating to the Raffle Draw, if invited to participate by the Promoter.

Winner Selection

The winning ticket will be drawn by an independent judge appointed by the Promoter for that purpose and the draw will also be supervised by an independent adjudicator. The Early Bird draw will take place in the same manner. In both draws, a second draw will take place if the first winner chosen is unable to

How to Claim

The winner must provide proof of Identity (Passport or Drivers Licence) and address verification (Utility Bill or Bank Statement)

If a winner does not claim the Prize, does not respond within 5 weeks of their details being posted on the website of the Promoter, or is unable to provide valid proof of identity and address verification, such winner waives the right to claim the Prize and the Prize will be awarded to the winner chosen in a second draw. Entrants agree and give consent that, if they win, the Promoter will have the right, without additional payment or permission, to use their name, age, the town of residence and likeness for the purposes of announcing the winner of the Raffle Draw and for related promotional purposes

Limitation of Liability
