

Terms And Conditions

The Promoter

The Promoter under a licence granted by Enniis Court Area is Newmarket Celtic FC of Newmarket on Fergus, Co Clare, Ireland.

Main Prize

Entry Requirements

How to Enter the Raffle Draw

Entry is by means of an online entry via <https://pallaslotteries.ie/product/newmarket499>.

A very limited number of printed tickets will be made available for non-internet users. On purchase of an online ticket for the Raffle Draw participants will receive an email with their raffle ticket number, all purchasers of tickets are automatically entered. At the point of purchase of the raffle ticket, purchasers will be asked to provide their first name, last name, email address, postal address, and contact number, which will be inputted online. Failure to provide any of the foregoing information or accurate contact details at the point of purchase may result in an inability on the part of the Promoter to contact the winner. The Promoter accepts no responsibility or liability to the winner for any failure on the part of the winner to provide full and accurate contact information. Raffle Draw tickets are priced at €98.00 plus €2.00 processing fee. By purchasing a ticket, entrants agree to be bound by these terms and conditions (please retain a copy of these terms and conditions for your reference) and to take part in any publicity relating to the Raffle Draw, if invited to participate by the Promoter.

Winner Selection

The winning ticket will be drawn by an independent judge appointed by the Promoter for that purpose on Sunday, December 11th at 8pm at a venue to be confirmed in Newmarket on Fergus, Co Clare. The decision of the Promoter as to the winner and validity of the entry is final and no correspondence with third parties will be entered into.

How to Claim
