

Terms And Conditions

The Promoter

The Promoter under a licence granted by Superintendent at Naas Garda Station is Naas Rugby Club, Forenaughts, Naas Co Kildare, Ireland.

Prizes

- The Prize is two premium tickets for all home six nations rugby matches from 2023 to 2027
- One winner wins both tickets
- A Maximum of 1,999 tickets will be sold
- Entries close at midnight on Wednesday, December 28th, 2022
- The draw will take place at 8pm on Thursday, December 29th, 2021
- An Early Bird draw will take place on Friday, November 11th at 8pm. The prize for this draw is two tickets for Ireland v Australia on November 19th. All tickets purchased up to midnight on November 10th will be included in both draws

Entry Requirements

The Raffle Draw is open to anyone aged 18 or over as at the date of the Raffle Draw who has purchased a ticket on or before the above closing dates. By taking part in this Raffle Draw, the participant is deemed to have read and understood the terms and conditions of this promotion and agrees to be bound by them. In the event of a club or syndicate winning, the person buying the ticket for the syndicate will represent the interest of the syndicate

How to Enter the Raffle Draw

Entry is by means of an online entry via <https://pallaslotteries.ie/product/5yearsat6nations>

A very limited number of printed tickets will be made available for non-internet users. On purchase of an online ticket for the Raffle Draw participants will receive an email with their raffle ticket number, all purchasers of tickets are automatically entered. At the point of purchase of the raffle ticket, purchasers will be asked to provide their first name, last name, email address, postal address, and contact number, which will be inputted online. Failure to provide any of the foregoing information or accurate contact details at the point of purchase may result in an inability on the part of the Promoter to contact the winner. The Promoter accepts no responsibility or liability to the winner for any failure on the part of the winner to provide full and accurate contact information. Raffle Draw tickets are priced at €48.00 plus €2.00 processing fee. By purchasing a ticket, entrants agree to be bound by these terms and conditions (please retain a copy of these terms and conditions for your reference) and to take part in any publicity relating to the Raffle Draw, if invited to participate by the Promoter.

Winner Selection

The winning ticket will be drawn by an independent judge appointed by the Promoter for that purpose on Thursday, December 29th at 8pm at a venue to be confirmed in Naas, Co Kildare. A second draw will take place if the first winner chosen is unable to meet the T&Cs or is unable to be contacted within 35 days of the draw taking place. The decision of the Promoter as to the winner and validity of the entry is final and no correspondence with third parties will be entered into.

How to Claim
