

# Terms & Conditions

## Caulry GAA “Start Solar” Draw

### 1 The Promoter

The Promoter under a licence granted by District Court Area of Athlone is Caulry GAA Club, its registered address at Carn Park, Mount Temple, Co Westmeath, Ireland.

### 2 Prize

The Prize is provision and installation by Start Solar Ireland of a 6KWP system using 15 Tier 1 All Black Solar PV Panels with 25 year warranty. Also included is 5KW Battery Storage along with a Myenergi Hot water diverter and Post BER assessment. Prize includes all costs and comes with 5 year workmanship warranty.

There is no alternative for the prize – the prize is provided “as is”.

### 3 Purpose

The purpose of this Fundraising event is to raise funds for the benefit of Caulry GAA. The organisers of the event shall not derive any personnel profit from the event.

### 4 Entry Requirements

**THE DRAW IS OPEN TO ANYONE WORLDWIDE STRICTLY AGED 18 YEARS OR OVER BUT ONLY COVERS INSTALLATION ON THE ISLAND OF IRELAND.**

Any tickets purchased by persons under the age of 18 years shall be declared null and void and shall not be included nor deemed to be included in any of the draws. Any such entry into the draws will be declared invalid and another ticket will be drawn in its place.

By taking part in this Fundraising event, the participant is deemed to have read and understood the terms and conditions of this promotion and agrees to be bound by them.

### 5 How to Enter the Smart Solar draw

Entry is by means of an online entry via <https://pallaslotteries.ie/product/startssolar>. A limited number of printed tickets will be made available for door-to-door sales and non-internet users. On purchase of an online ticket for the Smart Solar draw, participants will receive an email with their raffle ticket number - all purchasers of tickets are automatically entered.

At the point of purchase of the ticket, purchasers will be asked to provide their first name, last name, email address, postal address, and contact number, which will be inputted online. Failure to provide any of the foregoing information or accurate contact details at the point of purchase may result in an inability

on the part of the Promoter to contact the winner. The Promoter accepts no responsibility or liability to the winner for any failure on the part of the winner to provide full and accurate contact information. The tickets are priced at €29.00 plus €1.00 processing fee. This Fundraising event is limited to the sale of 3,499 tickets.

The decision of the Promoter as to the winner and validity of the entry is final and no correspondence with third parties will be entered into.

## **7 How to Claim**

The Promoter will use reasonable endeavours to contact the winners within 5 weeks of the fundraising event taking place using the contact details supplied upon purchase of the tickets, and the name of the winners will be posted on the website & social media platforms of the Promoter.

The Promoter will not enter into correspondence with third parties and will not use alternative contact details to those supplied upon purchase of the raffle ticket.

If a winner does not claim the Prize or does not respond within 5 weeks of their details being posted on the website of the Promoter, such winner waives the right to claim the Prize.

## **8 Publicity**

Entrants agree and give consent that, if they win, the Promoter will have the right, without additional payment or permission, to use their name, the town of residence and likeness for the purposes of announcing the winners of the Smart Solar draw and for related promotional purposes.

## **9 Restrictions**

If there are reasonable grounds to believe that there has been a breach of these Terms and Conditions by an entrant, the Promoter may, in its sole discretion, invalidate the relevant entry and disqualify the entrant from the event.

The prize must be accepted as offered. No alternative prize will be offered. The prize is not redeemable for cash. In the event of a dispute, the decision of the Promoter is final.

## 10 Promoter's Right to Modify or Cancel

The Promoter reserves the right in its sole discretion to modify, cancel, terminate or temporarily suspend this competition at any time without notification, and with no liability to any entrant or any third party other than refund of ticket price.

The Promoter reserves the right to increase the number of tickets to be sold.
