

Terms & Conditions

Ballymacelligott GAA – Ballymac30k Draw

1 The Promoter

The promoter under a licence granted by District Court Area of Tralee is Ballymacelligott GAA Club. The club's registered address is Arabella, Ballymacelligott, Co Kerry V92 AX58

2 Prizes

The Prizes are outlined below;

1 st Prize	€20,000

5 th Prize	€1,000

7 th prize	€500
8 th prize	€500

- There will be a bonus prize of a coaching session with Paudie and David Clifford for a club chosen by the winner. Please note that the club nominated must be a club in Ireland. This prize will be drawn first on the night of the draw
- The second ticket drawn will receive the 8th prize, the third ticket drawn will receive 7th prize and so on. All tickets will be entered in all draws – winners of the first eight prizes will remain in the draw for the 1st prize.

- The Early Bird draw will take place on Wednesday, December 27th at 8pm. It will be streamed on Facebook using a random number generator to select the winner.

3 Purpose

The purpose of this Fundraising event is to raise funds for the benefit of Ballymacelligott GAA Club. The organisers of the event shall not derive any personnel profit from the event.

4 Entry Requirements

- **THE DRAW IS OPEN TO ANYONE WORLDWIDE STRICTLY AGED 18 YEARS OR OVER.**
- Any tickets purchased by persons under the age of 18 years shall be declared null and void and shall not be included nor deemed to be included in any of the draws. Any such entry into the draws will be declared invalid and another ticket will be drawn in its place.
- By taking part in this Fundraising event, the participant is deemed to have read and understood the terms and conditions of this promotion and agrees to be bound by them.
- In the event of a club or syndicate winning, the person buying the ticket for the syndicate will represent the interest of the syndicate
- In the event of a business winning, a legal agreement on who is to receive the payment will need to be agreed before payout of the winnings

5 How to Enter the Ballymac 30k draw

- Entry is by means of an online entry via <https://pallaslotteries.ie/product/ballymac30k>. A limited number of printed tickets will be made available for door-to-door sales and non-internet users.
- On purchase of an online ticket for the Ballymac 30k draw, participants will receive an email with their raffle ticket number - all purchasers of tickets are automatically entered.
- At the point of purchase of the ticket, purchasers will be asked to provide their first name, last name, email address, postal address, and contact number, which will be inputted online.
- Failure to provide any of the foregoing information or accurate contact details at the point of purchase may result in an inability on the part of the promoter to contact the winner. The promoter accepts no responsibility or liability to the winner for any failure on the part of the winner to provide full and accurate contact information.
- The tickets are priced at €50.00 including a €2.00 processing fee.
- By purchasing a ticket, entrants agree to be bound by these terms and conditions (please retain a copy of these terms and conditions for your reference) and to take part in any publicity relating to the Ballymac 30k draw, if invited to participate by the promoter.
- Hard copy tickets must be retained as proof of purchase.
- There is no limit on the number of tickets which an Individual may purchase for said event.
- Once purchased, no refunds will be issued except in the event of cancellation of the draw.

7 How to Claim

- The promoter will use reasonable endeavours to contact the winners within 5 weeks of the draw taking place using the contact details supplied upon purchase of the tickets, and the name of the winners will be posted on the website & social media platforms of the promoter.
- The promoter will not enter into correspondence with third parties and will not use alternative contact details to those supplied upon purchase of the raffle ticket.
- If a winner does not claim the prize or does not respond within 5 weeks of their details being posted on the website of the promoter, such winner waives the right to claim the prize.

8 Publicity
