

Terms & Conditions

Clough Vision Group - 999 St Patrick's Weekend Draw

The Promoter

The promoter is Clough Vision Group, Clough, Ballacolla, Co Laois.

Prize

The Prize is €10,000 with one winner

- All tickets purchased before midday on Sunday, March 16th, 2025 will be entered in our draw unless all tickets are sold prior to this time
- The Prize is provided "as is"

The draw will take place on Sunday, March 16th at 8pm at a venue to be agreed and will be supervised by an independent adjudicator. A random number generator to select the winner and the draw will be streamed on Facebook.

Early Bird Prizes

- All tickets purchased before 4pm on Saturday 1st February, 2025 will be entered in our Early Bird draw
- The Early Bird prize provided for this draw is a Family voucher for €1,500 for Centre Parcs in Longford
- The Early Bird draw will take place on Saturday, February 1st at 8pm. It will be streamed on Facebook using a random number generator to select the winner.

Purpose

The purpose of this Fundraising event is to raise funds towards the future development of Clough Community Hall. The organisers of the event shall not derive any personal profit from the event.

Entry Requirements

- **THE DRAW IS OPEN TO ANYONE WORLDWIDE STRICTLY AGED 18 YEARS OR OVER.**
- Any tickets purchased by persons under the age of 18 years shall be declared null and void and shall not be included nor deemed to be included in any of the draws. Any such entry into the draws will be declared invalid and another ticket will be drawn in its place.

How to Enter the Clough 999 Draw

 - A limited number of printed tickets will be made available for door-to-door sales and non-internet users.
 - On purchase of an online ticket for this draw, participants will receive an email with their ticket number, all purchasers of tickets are automatically entered.
 - At the point of purchase of the ticket, purchasers will be asked to provide their first name, last name, email address, postal address, and contact number, which will be inputted online.
 - Failure to provide any of the foregoing information or accurate contact details at the point of purchase may result in an inability on the part of the promoter to contact the winner. The promoter accepts no responsibility or liability to the winner for any failure on the part of the winner to provide full and accurate contact information.
 - The tickets are priced at €100.00 including a €3.00 processing fee.
 - By purchasing a ticket, entrants agree to be bound by these terms and conditions (please retain a copy of these terms and conditions for your reference) and agree to take part in any publicity relating to the draw, if invited to participate by the promoter.

- Hard copy of paper tickets or soft copy of online tickets must be retained as proof of purchase.

 - Once purchased, no refunds will be issued except in the event of cancellation of the draw.

- This Fundraising event is limited to the sale of 999 tickets

How to Claim

- The promoter will use reasonable endeavours to contact the winners within 5 weeks of the draw taking place using the contact details supplied upon purchase of the tickets, and the name of the winners will be posted on the website & social media platforms of the promoter.
- The promoter will not enter into correspondence with third parties and will not use alternative contact details to those supplied upon purchase of the raffle ticket.
- If a winner does not claim the prize or does not respond within 5 weeks of their details being posted on the website of the promoter, such winner waives the right to claim the prize.

Publicity

- Entrants agree and give consent that, if they win, the promoter will have the right, without additional payment or permission, to use their name, the town of residence and likeness for the purposes of announcing the winners of the draw and for related promotional purposes.

Restrictions
